Re: Management Transfer of OID 2.16.124.113620.1.19, OID 2.16.124.113620.1.22 and NAEDRA to ANSI/IEEE/MC OID Oversight Group

Dear Messrs:

This letter is in response to requests made by ASC C12, SCC31 and MC to Future DOS R&D Inc. to issue a letter that confirms its intent to transfer management, control and rights to OID 2.16.124.113620.1.19, OID 2.16.124.113620.1.22 and NAEDRA to ANSI/IEEE/MC OID Oversight Group (OID COMMITTEE).

It is stipulated that conforming to the Canadian National Registration Authority, acting in accordance with standard Z243.110 Series 93, "Canadian OSI Registration Procedures and Guidelines" by the Canadian Standards Association, Future DOS R&D Inc. is the owner and administrative authority for the Object Identifier (OID) 2.16.124.113620.1.19 (<device-class-root-oid>) and OID 2.16.124.113620.1.22 (<application-context-oid>).

It is also stipulated that Future DOS R&D Inc. is the registered owner and administrative authority for the internet domain NAEDRA.ORG; and it is currently hosting the internet site WWW.NAEDRA.ORG.

It is also stipulated that Future DOS R&D Inc. is the user of the Trade Mark "North American End Device Registration Authority™".

Future DOS R&D Inc., herein, agrees to transfer management and/or administrative control of OID 2.16.124.113620.1.19, OID 2.16.124.113620.1.22 and NAEDRA to the OID COMMITTEE subject to the following conditions:

- (1) An OID COMMITTEE shall be formed.
- (2) The composition of the OID COMMITTEE, the use of the Domain Name NAEDRA.ORG and the distribution of OIDs shall be in accordance with the guidance provided in Draft ANSI C12.19-2008 (Annex K – Universal Identifier and Annex L -ANSI/IEEE/MC OID Oversight group and Certified Registrars)

and Draft ANSI C12.22-2008 (Annex D - Universal Identifier and Annex K - ANSI/IEEE/MC OID Oversight group and Certified Registrars).

Given that the OID COMMITTEE is not presently an Entity, Future DOS R&D Inc. will continue to provide services and protections for the NAEDRA Domain Name, the trade name and will host the NAEDRA web site under the management-control of the OID COMMITTEE. Future DOS R&D Inc. shall continue to do so until instructed to do otherwise by the OID COMMITTEE.
